ORDER


Acting in accordance with La. Const. Art. V, Sec. 1 and the inherent power of this Court and considering the emergency created by the forecasted inclement weather conditions,



ORDER

On motion of, and at the request of Clerks of Court Bridget Hanna (Ascension), Erin Hebert(Assumption) and Shane LeBlanc (St. James) and upon representation to the Court, that to remain in conjunction with the offices of the Twenty-Third Judicial District Court, it is recommended that the offices of the Ascension, Assumption and St. James Parishes Clerks of Court be closed Tuesday, March 22, 2022 at 12:00 p.m. due to the threat of severe weather. The Ascension, Assumption and St. James Parishes Clerks of Court will reopen on March 23, 2022 for regular business hours.

It is ordered, that, pursuant to the provisions of R.S. 1:55E(2), that the Offices of the Clerks of Court for the parishes of Ascension, Assumption and St. James be closed Tuesday, March 22, 2022 at 12:00 p.m. due to the threat of severe weather , and that Ascension, Assumption and St. James Parishes Clerks of Court will reopen on Wednesday, March 23, 2022 for regular business hours. Further, pursuant to the provision of this section, the Clerks shall attach a statement advising of the action to every petition or pleading filed in each Clerk's Office on the first day or part of a date his/her office shall be reopened when such petition or document relates to a cause of action, right of appeal, or other matters against which prescription could have run or time periods imposed by law could have expired.
